SECTION 3 - HAZARDOUS IDENTIFICATION

EMERGENCY OVERVIEW: Liquid or cream with slight odour, considered non-toxic
MOST IMPORTANT HAZARD: None
INHALATION: May cause irritation of mucous membranes and respiratory tract

SECTION 5 - STORAGE AND TRANSPORT

The following are instructions for the proper storage of Diffusimax10 kits and pre-mixed cream in distribution centres and in pharmacies.

Storage in Distribution Centres:

Maxima Pharmaceuticals ships Diffusimax10 kits and pre-mixed cream to distribution centres at a controlled temperature. Products may occasionally freeze during transport. If freezing occurs, allow the product to thaw at room temperature. Both kits and pre-mixed cream are acceptable for use after thawing. Compound A may solidify and appear cloudy if exposed to temperatures below 5°C and may remain cloudy after thawing. This is normal and does not affect the product.

Diffusimax10 kits and pre-mixed cream should be kept at room temperature in distribution centres. Shelf life at room temperature is five years. When possible, Diffusimax10 kits and pre-mixed cream should be shipped to pharmacies at room temperature.

SECTION 5 - STORAGE AND TRANSPORT (Continued)

Storage in Pharmacies:

Kit Storage

Both Compound A and Compound B are stable at room temperature. The kit can be kept intact at room temperature until use, but Compound B is solid at room temperature and needs to be refrigerated prior to use to allow it to liquefy. The optimal temperature for liquefying is 1-3°C. It may be convenient to store the Compounds separately: Compound A at room temperature and Compound B in the refrigerator. Once gel has been made by combining Compound A with Compound B, it should be stored at room temperature.

Accidental Freezing: Compound A may solidify and appear cloudy if exposed to temperatures below 5°C. It can be thawed at room temperature. Thawing can be facilitated by placing the capped bottle in a warm water bath (up to 37°C) and agitating intermittently. Compound A may remain cloudy after thawing. This is normal and Compound A can be used to prepare Diffusimax10 cream as per normal protocols.

Pre-mixed Cream Storage

Pre-mixed cream should be stored at room temperature.

Accidental Freezing: Separation of Diffusimax10 pre-mixed cream may occur if it is frozen. Cream consistency will be restored by mixing.

The stability of Diffusimax10 products is not affected by freezing. Unopened kits and pre-mixed cream have shelf lives of five years.

General Transport Information:

Diffusimax10 is not considered a dangerous good for transportation.
